Update on Payments

As we mentioned last Sunday, our pay structure will be shifting to quarterly instead of weekly payments. The price to practice is \$150. We are requesting the Q1 payments by January 31, 2025 to cover practices through March 30th, Q2 covers April through end of June etc. The payment due dates are as follows:

- Q1 due January 31st
- Q2 due April 1st
- Q3 due July 1st
- Q4 due Oct 1st
- Q1 due Jan 1st, 2026

Kimberly DeCiantis will be handling all payments. We are deeply grateful that she has offered to handle our youth finances in addition to the adult finances.
